


Today, we proudly introduce MicroDEP, a patented micro deposition technology designed for potent, low-dose APIs.

FROM INCONSISTENT ABSORPTION TO PREDICTABLE PRECISION

- Precise API Deposition: Controlled API droplets are precisely deposited onto a dissolvable thin film.
- Optimized Film Dissolution: The polymer film disintegrates upon mucosal contact for complete API release. MicroDEP dosage forms are designed to be dissolvable over a specific time, or designed to be non-dissolvable and easily removed.
- 3- Direct Mucosal Delivery: Sublingual/buccal route of administration bypasses the first-pass metabolism for reliable, systemic uptake.
